EcoLeague Participation Policies and Instructions

About the EcoLeague Program:

- EcoLeague is open to students in any academic area.
- Students may spend up to two non-consecutive semesters at other EcoLeague institutions during their sophomore, junior, or senior years.
- Students continue to pay full-time tuition to their home institution. Course Fees, labs, and room & board are paid to the host institution. Travel costs are covered by the student.
- Credits earned at EcoLeague institutions are transferred back to the home institution.
- Students are expected to return to their home institution after an EcoLeague exchange.
- Students planning to participate in an EcoLeague program must be prepared to assume a large amount of responsibility for completion of the required paperwork and communication with various school offices.

To Participate in an EcoLeague Exchange, Students Must Have All of the Following:

- Sophomore, junior, or senior standing
- Good academic standing and a career GPA of 2.6 or higher
- No academic or financial holds on their student account
- No incomplete grades for the semester prior to the one in which they participate in the EcoLeague exchange
- An account balance paid in full or covered by verifiable loans, aid, or payment plans

How to Participate:

1. File the completed "Request to Participate" form with your EcoLeague Faculty Representative by the deadline listed on the EcoLeague website.
2. Once approved, meet with your assigned academic advisor to discuss course choices at the other college.
3. Complete EcoLeague paperwork and submit forms **electronically via scan** to the EcoLeague coordinator at coordinator@ecoleague.org by the deadline that will be given to you in your approval email. Once your paperwork is completed, departments at both institutions will be notified of the upcoming exchange.
4. Confirm with the host school's Registrar that you are registered for courses.
5. It is the student's responsibility to pay course fees, labs, and room & board on the timeline given by the host college.
6. It is your responsibility to immediately notify the Registrar's office if any changes are made to the schedule once the EcoLeague exchange begins. If you withdraw/leave the host college during the semester, or decide not to attend, it is imperative that you inform the colleges immediately. Failure to do so may have significant financial consequences.
7. Credits will not officially appear on your home school's record until an official transcript of completed work is received from the participating college. *Transcripts will not be released if you have unpaid fees, fines, etc.*
8. Grades received at the host college will appear on your transcript. Some EcoLeague schools do not issue grades. In these cases, the grade will be recorded on an Satisfactory/Unsatisfactory basis.
